

# TEXAS 2011 STATE SERVICE PISTOL AND REVOLVER CHAMPIONSHIPS

Sponsored by Texas State Rifle Association  
Hosted by Bayou Rifles Inc.

NRA Registered Outdoor 900 (Service Pistol) Match, CMP Leg Match, NRA Registered Outdoor 900 (Revolver) Match, and NRA Distinguished Revolver Match

**Match Date:** Saturday, October 22, 2011

**Location:** Bayou Rifles Addicks range in Houston, Texas. The range is located at 1300 N Eldridge Pkwy, Houston, on the east side of Eldridge Parkway approximately 1/2 mile north of I-10 exit 753a; ten miles west of the I-10/610-West intersection. Location maps are available at the Bayou Rifles web site: bayourifles.org.

The range has covered shooting positions on a concrete slab firing line, individual shooting stands, and a wooden wind break fence behind the firing line. The 25 yard targets are mechanically operated for sustained fire.

**Eligibility:** Championship competitors must be members of the TSRA. Non-Texas residents may become a Match Member for a fee of \$10.00. A Match Member is a member of TSRA for the duration of the match.

Eligibility for the Distinguished Revolver Match is pursuant to Section 2 of the NRA Pistol Rules.

Eligibility for the Leg Match is in accordance with CMP rules.

**Entry Fee:** Service Pistol Championship \$35 (\$5 Pre-registration discount) [Juniors \$15]  
Revolver Championship \$35 (\$5 Pre-registration discount)[Juniors \$15]  
Leg Match \$20  
Distinguished Revolver \$10 [Juniors \$5]

Entry fee must accompany match entry. Complete entry fee will be refunded if canceled by October 15, 2011. A \$10.00 fee will apply to cancellations after that date.

Entries to be paid by a military unit or sponsor must have written authorization and billing instructions at the time of registration.

**Entries:** Registration is limited to 36 competitors. Shooters entering the full program will be given preference if range space becomes critical.

**Squadding:** Matches will not be squadded. Only one relay limited to 36 competitors will shoot.

**Entries close:** Entries must be received by October 15, 2011 to receive the pre-registration discount.

**Post Entries:** Post entries will be accepted until 8am on the day of match.

**Firing Schedule:** One relay starting at 9:00 am. The Service Pistol Championship (900) will be fired first followed by the CMP Excellence-in-Competition (LEG) match. After a meal break the Revolver Championship (900) will be fired followed by the NRA Distinguished Revolver match (NMC). A sighting period of 10 minutes will be conducted before each championship.

**Rules:** CMP Rules will be utilized for the Service Pistol Championship and the Leg Match. NRA rules will govern during the Revolver Championship and the Distinguished Revolver

**Match. Equipment for the Revolver Championship in accordance with Rule 3.2 - Any Center Fire Revolver.**

**Score Challenges:** A challenge fee of \$2.00 will be charged for each target challenged. The fee will be returned if the challenge is upheld.

**Course of Fire:** Each Championship will consist of the standard 900 point match as below:

Match #1 - Slow Fire (20 shots)  
Match #2 - National Match Course (30 shots)  
Match #3 - Timed Fire (20 shots)  
Match #4 - Rapid Fire (20 shots)  
Match #5 - Aggregate

The course of fire for the CMP "Leg" Match and the Distinguished Revolver Match is the National Match Course.

**Targets:** All slow fire at 50 yards on B-6 targets; timed and rapid fire at 25 yards on B-8 targets. Range is equipped with turning targets at 25 yards.

**Classification and Categories:** Current NRA classification will be used. Classes with less than four competitors will be moved up. Civilian, Police, and Service categories will not be used.

**Awards:** Winners of Match #5 will receive State Service Pistol and State Revolver Champion trophies/plaques. Awards are also given to first in class, High Senior, High Junior and High Woman. No competitor is eligible for more than one award in a class. First place for 4-6 competitors, second for 7-11 competitors, third for 12 or more competitors.

Awards for the CMP Leg Match in accordance with CMP Rules.

Awards for the Distinguished Revolver Match in accordance with NRA Rules.

**Match Bulletin:** The match results bulletin will become final 24 hours after completion of the match. All competitors will receive a copy of the final match results bulletin by regular mail or e-mail.

**Safety:** Shooters are obligated to be familiar with and to understand the meaning and intent of the rules, especially those concerning safety. Please review section 10, "Range Commands, Control & Operations" and section 18, "Competitor's Duties & Responsibilities". A violation of these rules can mean a loss of your privilege to compete. Alcoholic beverages are not permitted on the property.

**Brass Collection:** Competitors are required to police spent cartridges in their shooting area. Failure to comply with this requirement will disqualify the competitor. Use of catch nets is permitted.

**Concessionaire:** There will be no concessionaire at the range; however, there are suitable eating places within easy driving distance of the range. Drinking water will be provided during the match. There is no running water at the range. Restroom facilities are rustic.
