<b>Eligibility:</b>	Entry is open to all. USAS membership is not required for participation. However, USAS membership is required for record scores. Be sure to include your USAS Free Pistol classification on your entry form.
<b>Entry Fees:</b>	\$6 for members, \$10 for non-members. Entry fee includes USAS reporting fee and a results bulletin. Use the registration and Entry form located on page 3 of this program. Make check or money order payable to <b>Palo Alto Rod &amp; Gun Club</b> . Be sure to indicate your USAS classification, category, and membership number.
<b>Entries:</b>	Use the Registration and Entry form located on page 3 of this program. Please email your entry to Forrest Choy – <a href="mailto:forrest.hy.choy@gmail.com">forrest.hy.choy@gmail.com</a> . Be sure to indicate your USAS membership numbers and expiration dates on your entry form.  Due to range limitations, the total number of competitors is limited to eight (8) competitors. Entries will be ranked based on postmark. Walk-ins will be accepted at the Match Director's discretion.
<b>Closing Date:</b>	Entries must be received by the Wednesday preceding the scheduled match date.
<b>Cancellations:</b>	Cancellations must be received by Friday before the scheduled match date
<b>Post Entry:</b>	Post entries will be accepted until range capacity is reached. Walk-ins will be accepted at the discretion of the Match Director.

<b>Course of fire:</b>	Standing, 60 shots, 1 hour and 45 minutes at 50 ft. Ten (10) shots per bull. Automatic or manual crank carriers may be used. There is a 15-minute sighter period prior to firing for record.
<b>Schedule of Events:</b>	<p>There will be one relay of eight competitors. Start time denotes beginning of official 15-minute preparation/sighting period:</p> <p>Relay #1 will begin at 10:00 AM</p> <p>*additional relays will be added if necessary.</p>
<b>Squadding:</b>	All competitors will be squadded and assigned to a relay. Every effort will be made to assign competitors to a relay of their choice. Competitors will be notified of their entry and assignment before the match.
<b>Challenges:</b>	Challenge fees are \$1.00 per challenge.
