This competition is a **NRA Registered Match**. All regulations for registered matches will govern.

The 2012 NRA International Air Pistol Sectional National Indoor Pistol Championships are being fired at Sectional Tournaments throughout the United States. All local challenges and protests are to be resolved on the match site according to procedures outlined in Section 16 of the NRA Inter Pistol Rule Book. Each individual competitor and team firing in a Sectional will automatically be entered in the National Championship at no additional cost.

Competition Open to: All competitors. Individual or team may enter only one NRA Inter. Air Pistol Sectional during 2012. Membership in the NRA is encouraged but not required in order to participate in this match. Tournament officials may not compete in the Sectional at which they are officiating.

Teams will consist of three (3) firing members as defined in Section 2. **Team members must be designated before the individual matches commence. The individual match score will be used for the team score. The team match is not a fired match.**

Entry Fee: NRA Sectional Registration Fees include entry into the 2012 NRA Indoor Pistol Championships.

Individual Matches: \$20.00 per competitor.

Team Matches: \$18.00 per team.

Entries Close: Advance individual match entries must be received no later than **Sunday, 26 February 2012**. Team entries must be made prior to the start of any team member's firing in the individual match.

Post Entries: Individual Matches: \$25.00 per competitor.

Team Matches: \$24.00 per competitor.

Competition Capacity: Match is limited to 40 competitors. Entries will be accepted up to limit. Entries received after limit will be returned.

Rules: Current NRA Inter. Pistol Rules.

Gun: Air pistol – Any 4.5mm (.177 cal), Section 3.7.

Competition Course: Unlimited sighting shots and 60 record shots in 1 hr. 45 min (105 min) at 10 meters.

Targets: B-40/1 (4 sighting targets & 60 record targets). One shot per record target.

Classification: The NRA Inter Pistol Rules, Section 19 Classification shall govern for both individuals and teams. Each competitor must exhibit a valid classification card or Temporary Score Record Book prior to the start time. Unclassified competitors will fire in the Master class

Category: Open, Woman, Junior, Junior Woman, Senior, and Grand Senior.

Souvenir Award: NRA will provide a participation pin for each competitor.

NRA Sectional Awards: Schedule will be posted on site.

Local Awards: Individual open medals will be given to the top three Master, Expert, Sharpshooter, and Marksman. There must be a minimum of 5 competitors in a class, 8 or more to provide second place and 12 or more to provide third place. Special awards will be given to the top three Junior Men, top three Junior Women, top Women and top Senior.

Team medals will be given to the top Master, Expert, Sharpshooter, and Marksman. There must be a minimum of 3 teams in a class, 5 or more to provide second place and 8 or more to provide third place. Special awards will be given to the top three Junior Men teams, top three Junior Women teams.
